FACILITY: EIGHT LANE, 25 YARD INDOOR COURSE WITH NON-TURBULENT LANE LINES, SPECTRUM ACCELERATOR STARTING BLOCKS. EIGHT LANES WILL BE USED FOR COMPETITION. COLORADO ELECTRONIC TIMING SYSTEM WITH TOUCH PADS AND HORN START. EIGHT COLORADO BACKSTROKE START DEVICES AND EIGHT RELAY JUDGING PLATFORMS WITH SPEEDLIGHTS. FULL COLOR LED SCREEN COLORADO SCOREBOARD. SEPARATE WARM UP/WARM-DOWN AREA WILL BE AVAILABLE IN THE LEISURE POOL. THE MEET WILL BE RUN WITH A CLOSED DECK. ONLY SWIMMERS, CERTIFIED COACHES AND MEET PERSONNEL WILL BE ALLOWED ON DECK. NO FOOD WILL BE ALLOWED ON DECK. SPECTATOR SEATING WILL BE AVAILABLE IN THE NATATORIUM BLEACHERS AREA. SWIMMERS LEAVING THE POOL AREA MUST WEAR A SHIRT, PANTS AND SHOES. THE MINIMUM WATER DEPTH, MEASURED IN ACCORDANCE WITH ARTICLE 202.4.10C IS 12'6" AT THE START END AND 4'0" AT THE TURN END. THE COMPETITION COURSE HAS NOT BEEN CERTIFIED IN ACCORDANCE WITH ARTICLE 104.2.2.C(5).

MEET TYPE: AGE GROUP EVENTS, TIMED FINALS.

RULES: USA SWIMMING AND ARKANSAS SWIMMING, INC. RULES AND REGULATIONS WILL GOVERN THE MEET. ASI SAFETY GUIDELINES AND WARM-UP PROCEDURES WILL BE IN EFFECT.

ATTENDING COACHES: ONLY COACHES REGISTERED WITH USA SWIMMING WILL BE ALLOWED TO PARTICIPATE IN ANY COACHING CAPACITY. UNDER ARSI RULES, EACH TEAM MUST PROVIDE A COPY OF EACH ATTENDING COACH'S USA SWIMMING MEMBERSHIP CARD. ATTENDING COACHES SHOULD BE PREPARED TO SHOW PROOF OF USA SWIMMING REGISTRATION AND VALID CERTIFICATION IN CPR, FIRST AID, SAFETY TRAINING FOR SWIM COACHES, CONCUSSION TRAINING AND COACHES ADVANTAGE TUTORIAL.

ELIGIBILITY: ALL SWIMMERS MUST BE REGISTERED AS 2023 ATHLETE MEMBERS OF USA SWIMMING. NO ENTRIES WILL BE ACCEPTED WITHOUT CURRENT USA SWIMMING REGISTRATION NUMBER. SWIMMERS WHO ENTER AS PENDING OR APPLIED FOR MUST SEND THEIR ATHLETE REGISTRATION AND PAYMENT WITH THE TEAM ENTRIES. ON DECK REGISTRATION WILL NOT BE PERMITTED. IF YOU HAVE ALREADY SENT THE REGISTRATION AND FEE TO ARSI, PLEASE SEND A COPY OF THE REGISTRATION

FORM. THE AGE OF EACH SWIMMER AS OF FEBRUARY 17, 2023 DETERMINES AGE GROUP CLASSIFICATION FOR THE ENTIRE MEET.

SEEDING: ALL EVENTS WILL BE PRE-SEEDED, EXCEPT FOR THE 500 FREESTYLE AND 400 IM. THE 500 FREESTYLE AND 400 IM WILL BE DECK-SEEDED AND WILL REQUIRE POSITIVE CHECK-IN. POSITIVE CHECK-IN DEADLINE WILL BE THIRTY (30) MINUTES PRIOR TO THE ANNOUNCED START OF THE SESSION. THE 500 FREESTYLE MAY BE LIMITED TO THE FASTEST 48 SWIMMERS. HEATS WILL BE SWUM FASTEST TO SLOWEST.

FORMAT: EVENTS WILL BE SWUM WITH COMBINED AGE GROUPS BUT WILL BE SEPARATED FOR AWARDS. FRIDAY SESSION WILL BE MIXED GENDER.

ENTRY LIMITS: SWIMMERS MAY ENTER MAXIMUM SIX (6) INDIVIDUAL EVENTS PER DAY. MEET WILL BE LIMITED TO FIRST 400 SWIMMERS ENTERED. IF THE TEAM'S ENTRIES EXCEED THE 400 SWIMMERS LIMIT, ALL OF THE TEAM'S ENTRIES WILL BE ACCEPTED.

ENTRY DEADLINE: ENTRIES MUST BE RECEIVED BY WEDNESDAY, FEBRUARY 8, 2023. THE PREFERRED METHOD OF ENTRY IS BY HY-TEK DIGITAL FILES ACCOMPANIED BY EMAILED OR HARD COPY ENTRY SUMMARY SHEET. SEND TO ENTRIES @CASCRACERS.COM.

DECK ENTRIES: DECK ENTRIES WILL BE ACCEPTED BY THE CLERK OF COURSE UP TO 30 MINUTES BEFORE THE PUBLISHED STARTING TIME. COST IS \$10.00 PER INDIVIDUAL EVENT. A SWIMMER WHO IS NOT PREVIOUSLY ENTERED IN THE MEET MUST ALSO PAY THE \$25.00 SURCHARGE. DECK ENTRIES FOR EACH EVENT WILL BE PLACED IN OPEN LANES IN EXISTING HEATS IN THE ORDER IN WHICH THEY ARE RECEIVED BY THE CLERK OF COURSE. NEW HEATS WILL BE CREATED TO ACCOMMODATE DECK ENTRIES AS NECESSARY. THE ORIGINAL HEATS WILL NOT BE RESEEDED. THERE IS NO GUARANTEE THAT A DECK ENTRY WILL GET TO SWIM THE EVENT AND THERE WILL BE NO REFUND OF ENTRY FEES. NO EVENT WILL BE RESEEDED TO ACCOMMODATE A DECK ENTRY. A SWIMMER WHO SCRATCHES ONE EVENT AND ENTERS ANOTHER EVENT TO REPLACE IT WILL BE CHARGED DECK ENTRY FEES. DECK PASS MAY BE USED TO VERIFY CURRENT ATHLETE MEMBERSHIP.

SCRATCHES: NO MONEY WILL BE REFUNDED FOR SCRATCHES. A SWIMMER WHO DOES NOT REPORT BY THE FINAL CALL WILL BE SCRATCHED FROM THAT EVENT.

WARM-UP: ALL ASI WARM-UP RULES WILL BE FOLLOWED. ANY SWIMMER WHO DOES NOT ENTER THE POOL FEET FIRST DURING ANY PORTION OF A WARM-UP/WARM-DOWN PERIOD WHICH REQUIRES FEET FIRST ENTRY SHALL RECEIVE A WARNING FOR THE FIRST OFFENSE RATHER THAN A DISQUALIFICATION. DISQUALIFICATIONS ARE AUTOMATIC FOR SUBSEQUENT VIOLATIONS. IN THE SESSION IN WHICH THE PENALTY IS ENFORCED, THE SWIMMER CANNOT DECK ENTER AN EVENT TO REPLACE THE EVENT FROM WHICH THEY WERE REMOVED.

THESE WARM-UP RULES ALSO APPLY TO THE WARM-UP/WARM-DOWN AREA THAT WILL BE AVAILABLE DURING EACH SESSION. SWIMMERS MAY DIVE INTO THE POOL DURING A DESIGNATED SPRINT WARM-UP. SWIMMERS WITHOUT A COACH AT THE MEET MUST CHECK IN WITH THE MEET REFEREE AND WILL BE ASSIGNED TO A COACH DURING THE WARM UP PORTION OF THE MEET.

FINAL RESULTS: FINAL RESULTS WILL BE POSTED ON THE CASC RACERS WEBSITE & ARKANSAS SWIMMING WEBSITE.

AWARDS: MEDALS WILL BE AWARDED FOR 1ST THROUGH 3RD PLACES AND RIBBONS WILL BE AWARDED FOR 4TH THROUGH 8TH PLACES. MEDALS, RIBBONS, AND HIGH POINT AWARDS WILL BE GIVEN FOR BOYS AND GIRLS IN THE FOLLOWING AGE GROUPS: 8 & U, 9-10, 11-12, 13-14 AND 15 & UP. THE 1ST PLACE TEAM WILL BE AWARDED THE CHAMPION BELT. A SPRINT CHAMPION AWARD WILL BE GIVEN FOR BOYS AND GIRLS FOR THE MOST POINTS FOR EVENTS 101 THROUGH 108 IN THE FOLLOWING AGE GROUPS: 8 & U, 9-10, 11-12, 13-14 AND 15 & UP.

SCORING: INDIVIDUAL EVENTS: 9-7-6-5-4-3-2-1.

Rules/Safe Sport: USA SWIMMING RULES AND REGULATIONS WILL GOVERN THE CONDUCT OF THIS MEET. IT SHALL BE THE SWIMMERS' AND COACHES' RESPONSIBILITY TO ACQUAINT THEMSELVES WITH ALL INFORMATION CONTAINED HERE WITHIN.

ALL COACHES AND OFFICIALS EXPECTING TO RECEIVE ACCESS TO THE POOL DECK MUST BE PREPARED TO SHOW A CURRENT USA SWIMMING MEMBERSHIP CARD (DECK PASS IS ACCEPTABLE PROOF OF USA SWIMMING MEMBERSHIP). INFORMATION REGARDING THE APT COURSE AND THE BACKGROUND CHECK IS AVAILABLE ONLINE AT USASWIMMING.ORG/PROTECT. COACHES MUST PROVIDE PROOF OF CPR, FIRST AID AND SAFETY TRAINING FOR SWIMMING COACHES OR USA SWIMMING APPROVED EQUIVALENTS AND MUST HAVE SUCCESSFULLY PASSED THE REQUIRED BACKGROUND CHECK AND APT COURSE. COACHES MUST DISPLAY THEIR COACH MEMBERSHIP CARD WHILE ON DECK.

NO SWIMMER WILL BE PERMITTED TO COMPETE UNLESS HE/SHE IS A MEMBER AS PROVIDED IN ARTICLE 302. ANY SWIMMER ENTERED IN THE MEET MUST BE CERTIFIED BY A USA SWIMMING MEMBER-COACH AS BEING PROFICIENT IN PERFORMING A RACING START. FURTHER, THOSE PARTICIPANTS NOT PROFICIENT WITH A BACKSTROKE LEDGE MUST START EACH RACE FROM WITHIN THE WATER, AND WITHOUT USE OF THE BACKSTROKE LEDGE. IT IS THE RESPONSIBILITY OF THE SWIMMER OR THE SWIMMER'S LEGAL GUARDIAN TO ENSURE COMPLIANCE WITH THESE REQUIREMENTS.

NO SWIMMER WILL BE ALLOWED ON DECK WITHOUT A COACH MEMBER PRESENT. IF THE HOME CLUB COACH IS NOT PLANNING TO ATTEND EVENT, SWIMMER MUST BE ASSIGNED A SUPERVISING COACH. IF A SWIMMER ARRIVES WITHOUT A COACH, HE/SHE MUST FIND A WILLING COACH AT THE FACILITY TO SIGN SUPERVISION FORM BEFORE A CREDENTIAL CAN BE ISSUED.

THE SAFE SPORT PROGRAM IS USA SWIMMING'S COMPREHENSIVE ABUSE PREVENTION PROGRAM DEDICATED TO REDUCING THE RISK OF SEXUAL, EMOTIONAL, AND PHYSICAL ABUSE TO ATHLETES. COMPONENTS OF THE PROGRAM INCLUDE, BUT ARE NOT LIMITED TO, PROVIDING EDUCATION AND TRAINING, ENFORCING POLICIES, RULES, AND BEST PRACTICE GUIDELINES, PROMOTING HEALTHY BOUNDARIES AND MANDATED REPORTING OF VIOLATIONS.

THE MINOR ATHLETE ABUSE PREVENTION POLICY ("MAAPP") PROHIBITS APPLICABLE ADULTS FROM HAVING ONE-ON-ONE INTERACTION WITH MINOR ATHLETES THAT IS NOT WITHIN AN OBSERVABLE AND INTERRUPTIBLE DISTANCE FROM ANOTHER ADULT. ALL APPLICABLE ADULTS PARTICIPATING IN OR ASSOCIATED WITH THIS MEET, ACKNOWLEDGE THAT THEY ARE SUBJECT TO THE PROVISIONS OF THE USA SWIMMING MAAPP, AND THAT THEY UNDERSTAND THAT COMPLIANCE WITH THE MAAPP POLICY IS A CONDITION OF PARTICIPATION IN THE CONDUCT OF THIS COMPETITION.

PURSUANT TO USA SWIMMING RULES AND REGULATIONS AND FEDERAL LAW, IT IS EVERY MEMBER'S RESPONSIBILITY TO IMMEDIATELY (I.E., WITHIN 24 HOURS) REPORT ANY INCIDENT OF CHILD ABUSE, INCLUDING PHYSICAL OR SEXUAL ABUSE, TO LAW ENFORCEMENT AND THE U.S. CENTER FOR SAFE SPORT. REPORTING MUST OCCUR WHEN AN INDIVIDUAL HAS FIRSTHAND KNOWLEDGE OF MISCONDUCT OR WHERE SPECIFIC AND CREDIBLE INFORMATION HAS BEEN RECEIVED FROM A VICTIM OR KNOWLEDGEABLE THIRD PARTY. THE REQUIREMENT TO COMPLETE ATHLETE PROTECTION TRAINING IS AN ANNUAL REQUIREMENT. USA SWIMMING MEMBERSHIP WILL BE AFFECTED IF A NON-ATHLETE MEMBER OR ADULT ATHLETE MEMBER DOES NOT RENEW ATHLETE PROTECTION TRAINING ANNUALLY.

EACH CLUB IS RESPONSIBLE FOR THE CONDUCT OF ITS SWIMMERS. ANY PERSON WHO, IN THE OPINION OF THE MEET DIRECTOR OR MEET MARSHALL, IS HARMFUL TO OTHERS OR TO OTHER'S PROPERTY MAY BE REQUIRED TO LEAVE THE COMPETITION.

USE OF AUDIO OR VISUAL RECORDING DEVICES, INCLUDING A CELL PHONE, IS NOT PERMITTED IN CHANGING AREAS, REST ROOMS OR LOCKER ROOMS. ANY PERSON FOUND POSSESSING SUCH DEVICES IN THESE AREAS WILL IMMEDIATELY BE REMOVED FROM THE MEET WITH ALL FEES FORFEITED AND WILL BE SUBJECT TO FURTHER LSC AND/OR USA SWIMMING SANCTIONS AND PENALTIES.

OPERATION OF A DRONE, OR ANY OTHER FLYING APPARATUS, IS PROHIBITED OVER THE VENUE (POOLS, ATHLETE/COACH AREAS, SPECTATOR AREAS AND OPEN CEILING LOCKER ROOMS) ANY TIME ATHLETES, COACHES, OFFICIALS AND/OR SPECTATORS ARE PRESENT.
